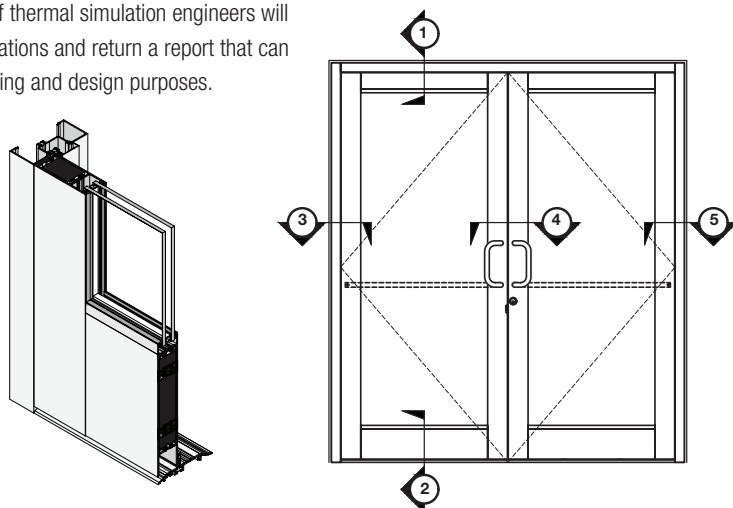

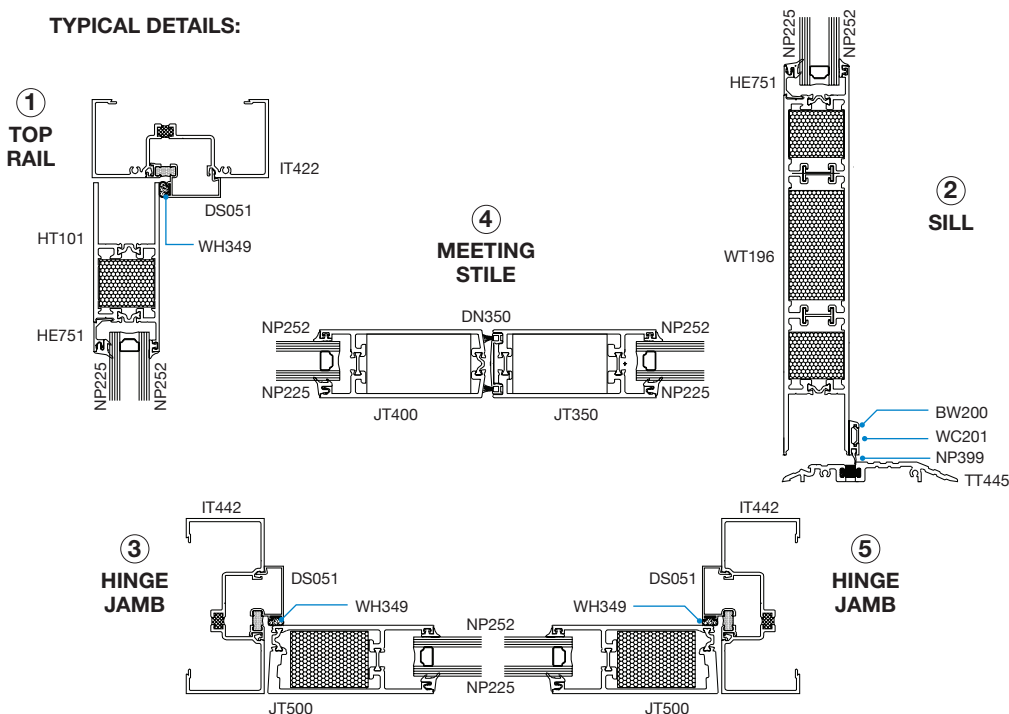
Mojave Doors - 400AT Double Door 10" Bottom Rail - IT451 Frame
